MIHS BOARD MESSAGE

This year is coming to a close, and we are on our way to normalcy. MIHS held three in-person events this year, and on December 13, the Board held an inperson meeting for the first time in three years! The slate of electors for the 2023 Board and Executive Committee will be presented to the Board for approval in January. After the slate is approved, the election will be held in February, and we will be off to the races.

It is likely that one of the primary missions for MIHS in 2023 will be to convert our website from the current platform to a new one. The look and feel of the MIHS website is fairly user-friendly to those who visit, but administering the website is a challenge. We have been informally researching our options over the past 2 years, including talking with another local section about their experience with another platform. We are hoping to land on a platform that offers a user-friendly interface for both administrators and visitors. Currently we have to (1) track registration and payment for events, and (2) communicate with the membership, as separate efforts. Currently, both of these efforts are a


